Meeting Minutes

1. Call to Order at 10:03 am

2. Review and Approve Agenda

4. Review 2021-22 Budget and Revenue Adoption

- The committee reviewed the status of the current budget
- Position control upload from the District has not taken place
- Academic salaries are at 80% compared to 87% last fiscal year
- Classified remains steady
- Benefits are a lower
- Supply spending, services, and equipment are lower, presumably due to campus closure
- A balance of 9 million to spend by June 30 on payroll
- June payroll crosses both fiscal years 20-21 and 21-22
- Revenue allocations from the District are slightly higher than FY 20-21 due to COLA
- An increased COLA is not confirmed until the State develops its budget
- Based on the DEMC new threshold recommendation, Adjunct Faculty spending is above 100% for salaries and benefits
- On July 1, a 2% increase across all bargaining units occurs
- Couple the Adjunct Faculty spending and the 2% increase is a wash for any previous savings
- Revenue for the 21-22 FY comes from the ability to charge indirect costs against CARES money in the unrestricted general fun
- CARE money is a short-term fix to a structural deficit
- LPC has a 2 million shortfall without the indirect
- The receipt of indirect cost is a moving target, with LPC receiving about 1.5 million
- Adjustments to position control may allow for some savings to cover the 5-7 hundred thousand difference
- The indirect process allows 47% of money spent charged back, i.e., \$1000 paid, \$470 received from indirect
- There are no changes to the materials, supplies, and discretionary budget for FY 21-22
- Discussion around consolidating services between the College has not made its way back to LPC
- A question posed is how does the District factor into streamlining costs or utilization of SCFF at their level
- A suggested way to work within the budget is to look for a way to streamline processes and implement technology
