Since the courses are being renumbered and updated, the program is being brought forward to reflect these changes. It is a non-substantial change to an existing degree (was never uploaded to CNET so it's listed as "new" there).

Mr. Kutil stated the units for this program are above 60 because this is allowed for certain licensing.

 Certificate of Achievement Emergency Medical Services EMT- Paramedic (Over 18 Units, CTE) – Program Update NSC. (Start date: Fall 2016)

Presented by Lisa Everett: This certificate is the same line-up of courses (as the program above) but without the GE.

Per Mr. Kutil, the Word doc will need to be amended slightly but the EMS programs will move forward for voting at the next meeting.

 A.S. of Automotive Electronics Technology (CTE) – Program Update NSC. (Start date: Fall 2016) Presented by Lisa Everett: It's a modification of the existing degree, and all courses were renumbered.

Mr. Kutil stated that he worked with Brian and Terry on this. He removed AUTO INTR to get total units to 60. He will make sure the course sequence is correct before bringing these back for a vote.

# 8. Status of AJ and BUSN Program Update – Craig Kutil

Mr. Kutil stated that these programs were approved last spring by the curriculum committee and Board approved in summer.

Lisa Everett stated that the Administration of Justice local AA degree had been updated and approved by the committee but not sent to State; they found that some of the course outlines had not been updated so it makes no sense to send the program to the State. So the revised program will not go forward. The old degree as it exists in the current catalog still stands.

Lisa Weaver stated that the Retail Management certificate requires a spreadsheet that shows the order that courses are to be taken. She stated that this was a non-substantial change to the certificate according to the PCAH (Program and Course Approval Handbook). She also stated that she will have this done by Dec. 11.

VP Bennie stated that she had spoken to Mr. Kutil about these programs that were sent to the Board as if they were ready for State approval. She stated that the Board would anticipate these items going to the State next, so she suggests that if items are not going to be sent to the State, that the Board be notified since the Board report is an official document. The Board will be notified of these issues.

## 10. Chair's Report

Mr. Kutil stated that he went to the Curriculum Regional meeting and learned that the State Chancellor's Office is moving to a new database starting July 1, and expecting to be done by September. There was a large amount of concern that it is not enough time for curriculum specialists at the college to be prepared. A lot of mistakes were made last time when the update happened. Some degrees were listed as certificates. This has not yet been corrected. VP Bennie has asked for help to no avail.

Mr. Kutil stated that CID has a new person in charge who appears to be highly knowledgeable. There is a 3 or 4 year backlog. Others seem to have the same issues we do with content and measurable objectives. The new person does not think that CID should alter the content and measurable objectives. Mr. Kutil will try to stay in touch with him.

Mr. Kutil also attended a course for new curriculum chairs. There is a concern that we have not had a specialist/analyst for 4 years. It is unrealistic for new chairs to know issues. He met with Dr. Russell many times regarding this issue. He does not have knowledge of these issues or access to the inventory and can't see it as the responsibility of a faculty member whose job it is to teach. He stated that the stuff is not easy to understand and would he not expect faculty members to understand the PCAH. As such, everyone has been doing the best they can. When information is not known it's not anyone's fault because no one is in place to know it.

### 11. Articulation Officer's Report – Marina Lira

Ms. Lira stated that approximately a year ago she briefly discussed the reciprocity agreement that went through Academic Senate. As ADTs have increased over the last year it has become the norm. Parents and students know about these degrees now. Students are taking courses to satisfy ADT requirements. If we have programs that did not utilize all the possible courses on the statewide TMC, in lieu of

sending out substitutions to all departments for every request, we thought it might be a simpler process to have counselors continue to do pass-alongs, the same as we do for any other degrees coming through. It is a transcript evaluations so that they can satisfy degree requirements.
