Presented by Marina Lira: This is one of about ten courses in the PSCN discipline that will be moving though. For this one some language was changed around to make it clearer. DE (hybrid) is being added. This will be one of the primary (campus) life courses. Two sections were offered this semester. Sections will increase over the next few semesters.

• THEA 52 (Introduction to Design, 3 units, 2.5 units lecture 0.5 units lab) – New Course Proposal: O, 1X, CSU T/GE, IGETC, C-ID. (Start date: Fall 2017)

Presented by Titian Lish: As the theater program expands it was noticed that there are missing components of some skills sets in some of our students. And there is not enough time in some of the other introductory courses to devote to developing a more artistic skill set for the students. So this course is a good solution. It works in the transfer model curriculum and our degree. As the CTE program grows, this course could be something that helps students stay a little bit longer.

Ms. Lira added that the course has to be UC transferrable before it's put on the IGETC list and she cannot submit it for UC approval until June 2016. But there is a chance that she might be able to submit earlier; she will check. Ms. Lish meant to also request UC transferability so this will be added.

But now it has to be revamped since the State no longer uses forms to upload proposals. The information that was on the State proposal forms must be captured in CNET so that it can be used to upload to the State. Kristy Woods worked on some new program screens in CNET and tried to incorporated information needed by the State Chancellor's Office. But some documents (TMC, ASSIST verifications, etc.) must still be uploaded to the State.

Ms. Hart stated that the pages are up and working and that as we work through, we might find things to fix.
