- 6. Discussion Items
  - Support for Updates

#### Craig Kutil

Craig Kutil stated that he put in a request to have two Flex Day sessions to work with faculty to update courses and programs in CurricUNET. He asked the committee for suggestions on how to support faculty in order to have curriculum updated in a timely manner. Updating curriculum has been an institutional goal for quite some time, which included hiring a Curriculum Specialist, but also hiring a Curriculum Technician. A Curriculum Technician would assist faculty in updating course outlines and programs, which is a role Craig is currently filling. Many disciplines have not been able to update their curriculum, because they do not have a full time faculty member (ex. OSHA, Foreign Language, Interior Design). There is money for part-time faculty to update courses. Dean Don Miller stated that while he has been at the college, he has consistently seen adjunct faculty get paid to do curriculum work. Per the new contract it will depend on if faculty have met their hours of professional responsibility of 1 hour per CAH per semester. Craig Kutil explained that while curriculum should be faculty driven, perhaps the Curriculum Tech Chairs from the Curriculum Committee should check in with faculty in their divisions regarding curriculum updates. Lisa Weaver suggested that if adjuncts were given more training in CurricUNET, they would be more interested in participating in curriculum. Craig Kutil hopes that adjunct faculty will participate in the Curriculum Flex Day sessions. Kristy Woods indicated that it would be helpful to be more transparent with faculty with regards to which courses need to be updated. Craig Kutil stated that the reason we are unable to update some of our programs, is that many of the course outlines are outdated and need to be first updated. It was clarified that courses should be updated by faculty in their own department, but can be assisted by other faculty.

### • Creating Course Update Cycle

### Craig Kutil

Craig Kutil explained that currently course updates are happening haphazardly. At the beginning at the next semester a list of all courses that should be updated will be generated. Many of the updates should be simple, but many faculty assume that course updates involve a lot of work. He and Roanna Bennie have discussed creating a cycle were each year a different division would be required to update their curriculum. That way all of the support would be focused on that one division. Other divisions could still be able to bring any new or modified curriculum to the committee at any time. Lisa Weaver stated that before there were cuts in the administration, staff assistants would contact departments letting them know when courses needed to be updated. Craig Kutil and Roanna Bennie signed a document from the Chancellor's Office certifying not only non-substantial changes for courses, but also stand- alone courses and substantial courses changes. The only courses that will in the future be reviewed by the Chancellor's Office will be new courses for new programs and non-credit. Craig Kutil asked the committee if it should speed up the current to the Year to Year minimum timeline for curriculum changes, given this new policy from the Chancellor's Office. Marina Lira stated that any unit, title, or GE change needs to be submitted to Assist. The changes that would not need to be submitted to Assist would include textbooks and effective date. Due to potential issues with the class schedule, it was

suggested that perhaps a taskforce, including Craig Kutil, Andrea Migliaccio, and Lisa Weaver, would look at this issue in more depth.

## Non-Credit Taskforce

## Craig Kutil

Craig Kutil

Craig Kutil stated that there will be three levels of non-credit that the committee will be able to define. Kristy Woods indicated that in the future the Taskforce will have more questions for the committee, especially with regards to positive attendance. The taskforce will bring information back to the committee for review and discussion. Craig Kutil stated that negotiations are still taking place at the district and it is unclear when they will be completed. The non-credit pages should not take too long to build in CurricUNET, as Governet has been very responsive recently to making updates to CurricUNET.

## • TOP Code

Craig Kutil stated in the future there will need to be TOP Code training for faculty. Institutional Research has hired a temporary CTE/ TOP Code specialist next semester to help us clean up some of our data. TOP Codes, Taxonomy of Programs, are how the state identifies our programs and courses. Whether the TOP Code is identified as CTE is directly tied to funding. Dean Don Miller also clarified that TOP Code also correlates to the minimum qualifications to teach a course and discipline. Craig Kutil explained that currently all new courses and program TOP codes are being selected by the faculty who created the proposal, with assistance from their Dean. The Curriculum Committee has not been involved in selecting TOP Code and it is not something that needs to be approved by the Curriculum Committee.

# • Chair's Report

Craig Kutil thanked everyone for all of their help this semester. Next semester the Committee will need to write up again their planning priorities, perhaps to include having reassigned time for faculty members to act in the capacity of a Curriculum Technician to help write curriculum. Craig Kutil will request to be the Curriculum Chair next year.
