## Discussion of Fall 14/Spring 15 additional courses

Review of data on classes added for fall. Discussion of the need to increase offerings in order to maximize enrollments and meet student needs. Finalized list of courses to be added to Fall 14 (late start/fast track). Deans will review staffing and provide final information to Andrea by Tuesday, 9/16.

Developed and prioritized list of course to be added in Spring 15. Goal is to get as many of the additional courses into the schedule that is being developed now. After review, the consensus was reached to add courses prioritized as 1s and 2s into schedule. LaVaughn is to meet with Dr. Russell to discuss possibility of also adding in courses prioritized as 3s. Deans will reviewing prioritized lists; there may be some minor tweaks based on available of faculty and discussions with discipline faculty.

#### **Intercollegiate Sports**

Jason Craighead and Dyan Miller informed the committee that the Kinesiology department is considering the addition of Women's Water Polo to the roster of intercollegiate sports offered at LPC. They are not looking at an increase in FTEF but may be shifting some FTEF within the department. The goal is to have the program onboard by Fall 15. There was also some discussion of the ongoing negotiations on coaching compensation. Concern was expressed about the need for more input to the process from LPC coaching faculty.

#### 15/16 Discipline plans

At our next meeting, we need to discuss the FTEF allocations that will be used when developing 15/16 discipline plans. With all the changes in discipline plans due to increases in FTEF and the need to make FTES goals, some disciplines have received additional FTEF for 14/15. This FTEF was on time only and we need to determine how the additional FTEF will be allocated for 15/16. Also, we need input from DEMC soon on the FTES targets and the associated FTEF allocation for 15/16. LaVaughn will discuss the urgency of this with the Chancellor prior to the Oct 3 DEMC meeting.
