#### 4. Old Business

#### **Climate Action Plan**

- An action plan spreadsheet consisting of 73 line items was shared with the committee
- The plan and action items originate from 2010
- A central goal was to reduce 20% of emissions by 2020
- By 2050 the goal is reduction of emissions by carbon zero
- Points of consideration moving forward are moving away from natural gas to warm the pool, installation of more sheeted parking structures, and energy storage
- Power generated during summer weekends was sold back to PG&E and helps with offset
- The goal to reduce vehicle miles travelled to campus was assisted by the installation of more EV chargers, partnership with Tri-Valley Wheels, and the move to online class in 2019
- The pandemic pushed the use of virtual meetings, office hours, and reduction of paper
- The committee suggested using the return to in-person campus activities as a benchmark for the continued reduction of miles traveled to LPC
- Prioritization of spreadsheet and annual review will take place annually
- It is important to note that new building projects moved away from the use of natural gas and the central utility plant

#### **LPC EV Charges**

- The committee decided move forward with a fee schedule electrical vehicle charges at LPC
- The proposed fee schedule was a 6-month flat fee for employees and a charge of 30 cents per kilowatt for the community
- Campus Safety will manage the ChargePoint system locally and utilize a vendor for maintenance of the chargers
- M&O will no longer maintain the chargers

- Employees will be charged twice a year on July 1 and January 1
- The committee discussed the potential conflict of interest of Campus Safety managing the EV charges locally and revenue funding their budget
- Next steps are review at the District Facilities' meeting, change to Admin Fees Policy and then routing for approval
- Tentative local management start date January 2022

#### **Colombian Mammoth Bone Update**

- The mammoth bones are in their new cases
- The cases require a securing once set-up is complete
- For context, general information was posted in the area
- The proposal includes use of five informative panels to narrate the themes of inspiration, California history, ecosystems, human impact on their environment, and the change it creates
