4. Campus Safety reports

4.1 Campus Safety Statistics (see page 3 of minutes)

Sean reported on statistics for the months of Jan. and Feb (combined). Major concerns: Sexual battery that was substantiated, police are handling student currently not attending; theft (459) of computers from labs, IT currently looking into locking mechanism for desk top computers.

4.2 Emergency Action plan

Jim Yoke presented group with a revised Emergency Action Plan draft #3. Focused on page 10 and page 11.

There was discussion on Evacuation Area Head Count Form (page 10) and the ability to use it effectively. OSHA mandates a that a form such as this be used during an evacuation to account for staff. Recommended to add the word "staff" to the title.

Discussion on Evacuation Drill Evaluation Form (page 11) which would be completed by staff. Recommended to add the words "of employees" to question 8 and add a question related to effectiveness of Everbridge notification (text, phone, and email). Recommended to use GoogleDocs or some other type of electronic means to capture data.

Briefly discussed pages 8 & 9 which will require specific procedures; need to be sure they can be put into practice. Sean and Jim will be working on these.

Send any thoughts or ideas to Jim within the next couple of weeks.

4.3 Emergency Operations Plan

Jim reported that he is continuing to work on this.

Standard Operating Procedures are the "how to" and will come last. Shelter Agreements will be prepared to go to the Board by June; American Red Cross has done walk-through on campus.

Communication Development continues with EBRCSA (East Bay Regional Communication System Authority) which will allow LPC, Chabot, and the District to talk to each other during an emergency; use of satellite phones is being explored; continued use of Everbridge (challenge is to

ensure all staff are registered; Amateur radio (ham) is an active viable station which may happen far into the future.
