Meeting Minutes

1. Welcome

Rajinder Samra opened the meeting at 2:36 p.m.

2. Review and Approval of Agenda

The agenda was approved as presented. Eddy/Garcia.

3. Review and Approval of Minutes

The 12/14/17 minutes were approved as presented. Eddy/Garcia.

4. Californians and Higher Education – 2017 Statewide Survey Results by the Public Policy Institute of California

A survey was done in October 2017 of 1,107 individuals in California. Nineteen minutes was the average phone call. The survey was conducted in English and Spanish. A power point was shown with data depicting California community colleges versus California State Universities versus Universities of Californian most instances California community colleges ranked highest. It was discussed that four-year college degrees and the debt that comes along with them are viewed negatively. People are skeptical that a degree is worth the money. Women think college education more important than men do. Latinos think college education is important versus other race/ethnicities. This information can be used for marketing LPC to the potential local population.

5. **2017 CTE Employment Outcomes Survey**

A power point was provided. Data shown included statistics (early 2017) for statewide vs LPC who earned certificates, vocational degrees or 9 CTE units. Focused on tech education. Majority have one job. Older students likely to make more money and less likely to transfer. Strong data evidence that student success is showing.

6. Governor's Proposal for a Fully Online Community College

Still in the proposal stage and will be certificates only. LPC is working on a fully online degree. LPC online percentage students - 10% of enrollments. 10% could be both in person and online. 1/3 students have taken an online class. Will this effect funding by FTES? There may be budget implications if online college takes away students. It was suggested why not give this money to CCCs to build out their 100% online degree programs. There will be hearings on this. This is only a proposal. The college would be housed at state chancellor's office.

7. Partially Performance-Based Funding Model

Focus on outcomes. STES enrollments failing to capture. Proposing new funding model. Base grants 50% enrollment based. 25% if low income. 25% number of degrees, certificates. LPC needs to do a better job at getting students to apply and get their degrees/certificates. This is district enrollment so includes Chabot.

8. Local Budget Allocation Model

BAM handout was given. Chabot gets \$500,000 to help with nursing and dental programs. Subsidizing. \$200,000 less comes to LPC per year. 10% of their students are nursing majors. DO and M&O get their cuts. The rest is split between colleges by FTES. Make recommendations of changes at the March meeting.
