I've received and reviewed your recommendation for funding of the FY23 instructional equipment requests. Thank you to the committee for their time and commitment to the process of evaluating and ranking these requests during fall 2022. I understand the deliberation process can be challenging and time-consuming, and I appreciate your collective diligence and desire to be equitable to the requestors who have submitted the requests, but also to the students who are the benefactors of the equipment. **After reviewing RAC's recommendation and considerations relevant to the rankings, I support the committee's recommendation to purchase the 32 items on the next page (page 2) for a total allocation of \$1,363,495.02.**

These purchases will be funded using Bond & Physical Plant funds, the State's Instructional Equipment funds, as well as Lottery funds. The rationale to support the allocation of resources to support the purchase of these items are based on the following considerations:

- Supports the College's mission and institutional planning priorities
- Program/department need
- Contributes to and/or supports student learning and success

Moving forward, I encourage the committee to assess items that have a continued cost of ownership and inquire from the requesters how these costs will be met. This information should be taken into consideration when ranking requests in the future as large unfunded, continued costs may create budgetary challenges for our institution.
