### 3. Industry Update

#### New Technology

Rance Haig of Red Legged Frog Productions emphasized that it is important for student to have a solid "lighting" and "sound" knowledge base along with tools for recording like ProTools.

Ian Brekke of LPC agreed and shared with the advisory that LPC is unable to provide ProTools certification coursework because LPC does not have an expert on staff. He said that Logic is more widely utilized which is what LPC offers.

Keith Hatscheck of UOP agreed that lighting and sounds is growing as is live entertainment. Possibly a bridge with Music Technology with knowing the difference between operating systems. Technology transfer within the occupation is important.

Taicheng Chen of MTAC suggested a piano teaching software "Tone Row" which is easy to access through common technology; and it clearly expresses dynamics and articulation of playing between the student and the teacher.
