  - **SAO Process**
    - Pick up the discussion again
    - Process to report for Accreditation; but allow folks to collect SAO data however they like (eLumen is 1 option).
    - Documented in Program Review; using data to improve services. New standards: Calling on *disaggregated* data.
      - Student Svcs: Work with IR on survey creation
      - For accreditation: Does your process do what we expected it to? Program Review is the best way.
        - Survey results could be included as a Program Review appendix
        - A Student Services Division shared drive could house these.
