# ANTICIPATED POWER OUTAGE

CLPCCD Maintenance & Operations (M&O) recently announced that the majority of the Las Positas College campus will be without electricity or will operate with limited electricity following the conclusion of summer term 2019. The exact dates have yet to be determined. The reason is to replace the electrical power system switchgear that controls electricity to the entire campus. At this time, it is anticipated that Buildings 100, 1600, and 1700 (partial list) will have electricity but may operate with no air conditioning for approximately one week. The administrative team is working on the logistics to prepare for this major upgrade. Additional information is forthcoming.

## **GUIDED PATHWAYS STUDENT VOICES RETREAT #2**


