#### ADMISSION APPLICATION UPDATE

The CCCApply admission application for summer term and fall semester 2020 will go live on Tuesday, October 1, 2019. New and returning students should complete and submit the admission application as soon as possible to provide ample time to view the new online student orientation, complete the online guided self-placement, and obtain a student educational plan prior to course registration in April 2020. Students who complete the three core services of orientation, assessment, and student educational plan will receive priority registration. Students in need of in-person assistance should be referred to the Online Service Center (OSC) adjacent to the Admissions & Records Office.

#### FINANCIAL AID APPLICATIONS UPDATE

The Free Application for Federal Student Aid (FAFSA) and the California Dream Act Application (CADAA) will go live on Tuesday, October 1, 2019 for the 2020-2021 Award Year. New, continuing, and returning students are encouraged to complete and submit the financial aid applications prior to the California financial aid priority deadline of Monday, March 2, 2020. The financial aid applications are required for federal student aid, most state-based financial assistance, and institutional aid. Students in need of in-person assistance should be referred to the Online Service Center (OSC) adjacent to the Admissions & Records Office.

#### **CREDENTIALS SOLUTIONS**

On Monday, September 9, 2019, the Admissions & Records implemented Credentials Solutions with the assistance of Information Technology Services. Credentials Solutions is an automated transcript ordering service available for students and alumni to request official transcripts. The first two official transcripts will remain free of charge but have to be requested directly from the Admissions & Records Office. Additional official transcripts are available for a fee through Credentials Solutions. Students may print unofficial transcripts from CLASS-Web free of charge.

#### **CHATBOT**

In September 2019, the Financial Aid Office launched "Chatbot" and its name is "Andi." Chatbot is technology that mimics human conversations online in an automated fashion. Frequently asked questions and their corresponding answers are drafted by experts and are then assigned advanced algorithms to deliver high-caliber customer service to online users. If you haven't seen or used Chatbot, you are encouraged to do so. The Admissions & Records Office and the Counseling Department will soon be embarking on their own Chatbot in the coming months. The goal is to reduce telephone wait times, deliver consistent quality customer service, and ensure comparable service for online students.
